- 5. Pre-bid meeting shall not be held.
- 6. Sealed bids are not allowed.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 on 19/01/2021 (2077/10/06) at the office of "Makawanpurgadhi Rural Municipality, Makranchuli, Makawanpur". Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security, amounting to a minimum as mentioned in table below which shall be valid for 30 days beyond the validity period of the bid.
