- 6. Sealed bids must be submitted to the office "Makawanpurgadhi Rural Municipality, Makranchuli, Makawanpur" by hand on or before 12:00 noon on 12/04/2020 (2076/12/30). Bids received after this deadline will be rejected.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 on 12/04/2020 (2076/12/30) at the office of "Makawanpurgadhi Rural Municipality, Makranchuli, Makawanpur". Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security, amounting to a minimum as mentioned in table below which shall be valid for 30 days beyond the validity period of the bid.
